4. The Grant is Subject to the adjustment on the basis of Utilization Certificate in the prescribed proforma submitted by the University/Institution.
5. The University / Institution shall maintain proper accounts of the expenditure out of the Grants which shall be utilized only on the approved items of expenditure.
6. The University / Institution may follow the General Financial Rules, 2017 and take urgent necessary action to amend their manuals of financial procedures to bring them in conformity with GFRs, 2017 and those don't have their own approved manuals on financial procedures may adopt the provisions of GFRs, 2017 and instructions/guideline there under from time to time.
7. The Utilization Certificate to the effect that the grant has been utilized for the purpose for which it has been sanctioned shall be furnished to UGC as early as possible after the close of current financial year.
8. The assets acquired wholly for substantially out of University Grants Commission's Grant shall not be disposed or encumbered or utilised for the purposes other than those for which the grants was given without proper sanction of the UGC and should at any time the University ceased to function, such assets shall revert to the University Grants Commission.
9. A Register of Assets acquired wholly or substantially out of the grant shall be maintained by the University in the prescribed proforma.
10. The grantee institution shall ensure the utilization of grants-in-aid for which it is being sanctioned / paid. In case of non-utilization/part utilization thereof, simple interest @ 10% per annum, as amended from time to time on the unutilized amount from the date of drawal to the date of refund as per provisions contained in General Financial Rules of Govt. of India, will be charged.
11. The University / Institution shall follow strictly the Government of India / UGC's guidelines regarding implementation of the reservation policy [both vertical (for SC, ST & OBC) and horizontal (for persons with disability etc.)] in teaching and non-teaching posts.
12. The University / Institution shall fully implement the Official Language Policy of Union Government and comply with the Official Language Act, 1963 and Official Languages (Use for Official Purposes of the Union) Rules, 1976 etc.
13. The sanction is issued in exercise of the delegation of powers vide UGC Order No. 114/2014[F.No. 10-11/12 (Admn. IA & B)] dated 27-5-2014.
14. The University /Institution shall strictly follow the UGC Regulations on curbing the menace of Ragging in Higher Education Institutions, 2009.
15. The University / Institution shall take immediate action for its accreditation by National Assessment & Accreditation Council (NAAC).
16. The accounts of the University / Institution will be open for audit by the Comptroller & Auditor General of India in accordance with the provisions of General Financial Rules, 2017.

17. The annual accounts i.e. balance sheet, income and expenditure statement and statement of receipts and payments are to be prepared strictly in accordance with the Uniform Format of Accounting prescribed by Government.
18. This issues with the concurrence of IFD vide Diary No. 4483 (IFD) dated 13-01-2022
19. This issues with the approval of the JS(IC), UGC vide Dy. No. 93888 dated 01-02-2022 for the financial year 2021-2022.





The 8' Android tablets were given to all Students to enable them for online learning. The faculty members prepared and uploaded E-content in the form of PPT, pdf, video, animations, workbook and handouts. Course delivery was done through MS teams meetings as live sessions or Recorded videos. The faculty members handling their courses with 50% live sessions and 50% video sessions.</p> <p>Students attendance is maintained for both live and recorded video sessions.</p> <p>Doubt Clarification Sessions (DCS) is conducted at least once in a week.</p> <p>All Formative Assessments (FA) and Quizzes are conducted through MS forms. Internal examinations are conducted using MS Forms as per the schedule released by COE office. End semester examinations are received through online portal with multiple choice questions pattern. Periodic feedback from students and faculty members are received through online portal for further improvement. Laboratory courses related to programming languages such as C,C++, Java, Python etc. were conducted using e-Learning@meet Moodle portal with internal server hosted. Periodic audits were conducted to ensure the delivery of content, conduct of assessment, engagement of students and continuous improvements were made. Periodic online meetings were convened with all stakeholders of online education to get feedback and implement improvement measures. Due consideration was given to all students with respect their engagement in online learning to overcome difficulties posed by network and hardware issues. The online learning design considered the difficulties such as bandwidth, network availability, data usage and device compatibility. Using online learning mode entire course contents required for the syllabus coverage in majority of the courses both theory and practical were completed. However a small portion requiring physical presence of students in designate laboratories could not be accomplished and hence equivalent exercises were proposed by faculty members and conducted using virtual labs. Recommendations of UGC, AICTE and Anna University with respect to online learning were carefully customized and implemented while conducting courses online. In-short the challenges posed by the COVID 19 pandemic enabled the institution to explore various avenues of learning in the online mode and it has so far proved to be very successful.</p>
