Policy document for Green Campus Initiatives

1. INTRODUCTION

A "green campus" is a location where environmentally friendly actions and instruction work together to promote sustainable growth. By combining traditional and tried-and-true methods with the green campus concept, a college can lead the way in "forward delivery" by minimizing the use of energy and water consumption on campus and handling waste, transportation, air pollution, etc. in an efficient manner. In order to support the green campus plan, MCET developed a policy, and it requires all of its partners to follow it.

2. POLICY OBJECTIVE

In order to provide a safe and healthy workplace, it is important to raise consciousness about "reducing" the exploitation of natural resources, maintaining environmental development in all actions undertaken by its stakeholders.

3. SCOPE OF THE POLICY

The institution works to promote a green and clean campus to lessen the direct effect on the environment system. One way it does this is by

- Constantly planting more trees inside the campus to cover unused areas and promote clean air inside the campus.
- 2. Setting up and keeping a waste water management system on campus, which will aid in the removal of suspended materials and allow the reuse of treated water for campus landscaping? Waste water cannot be dumped anywhere; instead, it must be put to good use.
- 3. Installing Solar Power Plant/Bio gas plant to enable renewable energy generation and minimize the dependency on fossil fuels. The college keeps installing solar energy panels/solar water heaters /solar street lights on regular basis as part of continuous development.
- 4. Installing rainwater harvesting terminals to replenish groundwater where it may be feasible. Establishing facilities for bore wells or open wells to receive collected water.
